Purchaser agrees to the following:

1. This cat/kitten will never be sold, transferred, leased or given away, nor sold to any pet shop, research laboratory or similar facility.
2. This cat or kitten will be kept indoors and not be allowed to roam freely outside.
3. This cat or kitten is purchased for Pet Breeding Show .
4. If purchased as a pet, Purchaser agrees to neuter or spay this cat between the ages 4 or 30 days after purchase and agrees that this cat or kitten WILL NOT be used for stud or breeding if this cat or kitten is use as stud or breeder buyer agrees to paid \$2,000 to the seller.
5. If this cat or kitten is found to be neglected or mistreated, Purchaser will surrender said cat or kitten to seller.
6. This kitten will receive excessive amounts of tender loving care, will be fed the best possible diet, will receive substantial amounts of entertainment, and will be treated with the utmost respect so that he/she may realize its full potential.
7. This cat or kitten cannot be shown without written permission of the seller.
8. No Cash Refunds.
9. If this cat is purchased as a breeder, Purchaser agrees to breed this cat only with other Bengals.
10. See a vet certificate.
11. This cat or kitten is being fed Royal Canine kitten/ Dry Food and Science Diet Natures Best and Fancy Feast Chicken in Gravy for a treat.



Guarantees

This cat/kitten is guaranteed to be of sound health upon arrival. It is guaranteed for a period of 72 hours from the time purchase (arrival) if vet- checked within that time.

It is recommended that the new cat/kitten be in quarantine for 2 weeks. If it is found to be medically deficient with an untreatable or life-threatening problem, it must be reported to the seller immediately. Upon its return, it will be replaced with another kitten/cat of equal value or the purchase price will be refunded. If no replacement is available at that time, seller will have 6 months to furnish satisfactory replacement. The cat or kitten cannot be returned after the guarantee period has expired and/or it has been exposed to another cat. Under no circumstances is a kitten/cat to be destroyed prior to notification by the buyer to the seller. If the cat/kitten dies within the guarantee period, despite medical treatment, compensation will be made ONLY if a veterinarian certifies the cause of death. All veterinary fees are sold responsibility of the buyer.

This cat/kitten is guaranteed against congenital defects for 6 months. Should this cat die within that time as a direct result of a congenital defect, the cat/kitten will be replaced Only if an appropriate necropsy is performed by a licensed vet and a vet's certificate is provided as proof of cause of death. A replacement will be made of a cat of comparable quality and value, as available, at the discretion of the breeder. Due to many factors involved in rearing and caring for this kitten that are beyond the control of the seller, there are no guarantees on fertility or temperament.

There are no guarantees that the kittens sold as show quality, will necessarily win at the shows, since there are many factors involved in winning... like politics, competition, regional trends, grooming, socialization of the cat, and individual judges' perception of standard.

If the buyer at any given time decides to sell this cat/kitten, the seller will be given the first opportunity to buy the said cat/kitten at ½ the purchase price; otherwise it will be spayed/neutered before being placed with anyone else.

This contract is legally binding to all parties involved. It applies only to the buyer and the seller in this transaction and is non-transferable to other parties. If this cat/kitten is resold to another individual, this contract is null and void.

If the buyer or seller commences any legal action as a result of this contract, the buyer agrees that the place of venue of such action shall be the State of Florida in Kissimmee, FL, or Puerto Rico; any legal fees incurred in upholding this contract will be paid by the buyer.
